**Re: Austrian membership in the AEMH**

Dear President Dr. Lies,

The Austrian Medical Chamber herewith would like to inform the AEMH as follows:

The Austrian Medical Chamber and VLKÖ, present member of AEMH, have reached agreement that the two organisations will represent Austria jointly at the AEMH from January, 1<sup>st</sup> 2008.

As the Austrian Medical Chamber represents the larger number of senior hospital doctors in Austria, the two organisations concluded that the Austrian Medical Chamber will exercise the voting right in the AEMH.

Membership fees will be borne entirely by the Austrian Medical Chamber from 2008.

Prim. Univ. Doz. Dr. Robert HAWLICZEK has been nominated as the Austrian Medical Chamber's AEMH delegate.

Prim. Univ. Prof. Dr. Reinhart Waneck, President of VLKÖ, supports our initiative and has indicated to us that the VLKÖ will inform the AEMH per separate letter of this change in Austrian representation in the course of autumn.
