AEMH Closing of Accounts 2007

To the Members of the AEMH Board,

Please find here attached the financial situation of the AEMH as per 31 December 2007. The closing of accounts shows that the deficit budgeted for 2007 (€ 2.475) is inferior to the accounted deficit (€ 8,528.91), thus a difference of (€ 6,053.91), which is caused by

1 / **The bank interests** amount € 1,100 (reimbursement of DEXIA bank fees), the budgeted amount is € 3,000)

2 / **Interpretation costs** – The meeting in Vienna: the expenses exceed the budgeted amount for 2007 (consciously understated as in the precedent years).

3 / Exceptional expenses in 2007 :

- The costs for the **reconstruction of the website** in the course of 2007 amounted € 4,056.56, whereas the budgeted amount was € 1,000 for maintenance costs.

- **Office removal** from Rue de La Sciences to Rue Guimard represent € 580.80 of exceptional not budgeted costs.

We draw your attention to the fact that the reserves of the Association deplete continuously. The AEMH should take measures to be able to face its indispensable expenses and some possible exceptional costs.

These measures could consist of increasing the annual membership fees and/or an exceptional contribution in order to allow restoring the reserves. We recommend that the amount of the reserve should equal the expenditures of one financial year.




having audited the accounting of the AEMH for the year 2007, declare hereby that all
