### 1. Information regarding the tender on CPD

#### CPME STEERING A TENDER ON CONTINUOUS PROFESSIONAL DEVELOPMENT

**T**he CPME, as the leader of a consortium composed of [CED](#), [EFN](#), [EMA](#), [EPHA](#) and [PGEU](#), won a European tender, concerning the review and mapping of continuous professional development (CPD) and lifelong learning for health professionals in the EU and the EFTA/EEA countries. The final result of the project aims to explore the existing evidence base of CPD practices and identify emerging trends to provide a more comprehensive European overview. Another important aspect will be the provision of greater transparency and the improvement of mutual understanding of CPD systems and practices in the EU. In the coming weeks representatives of the consortium will go to Luxembourg to the Executive Agency for Health and Consumers to sign the contract and launch activities for the next 10 months of project execution.
