Report 2015

Since fall 2015, Belgium has a centre right government (more right than centre).

The Minister of Health is a general practitioner, a woman who carries weight!!

Apart from the now usual cut in the budget for healthcare the main problems we knew since last year are:

1. About a half of the students who achieve their master will not find the possibility to practice. Because the “numerus clausus” in the number of doctors admitted to practice and the lack of a registry from the medical profession and particularly the number of doctors who actually practice.

2. The minister of Health is preparing a new system of financing the hospitals (most of them are bankrupt) probably based on an “all-in” system. A revolution!

The profession worried about that because new system often means a way to make budget savings to detriment of the doctors and the patients.
