State of affairs: The European Court of Justice has ruled in the frame of the Working time directive 93/104 that on-call duties of doctors have to be considered as working time.

3 October 2000: SIMAP case, 9 Sept. 2003: Jaeger case. The EU Commission has launched a consultation on EWTD from January till end of March 2004 in view of a possible amendment of the Directive.
