Call for an Exceptional Financial Contribution

Following a proposal of the Norwegian delegation submitted at the 60th Plenary Assembly of 20-21 April 2007, the President and the Board of the AEMH call on the AEMH Member Delegations, to approve a one-off contribution fee in order to cover the existing deficit and to restore the reserves in compliance with the advice of the external auditors.

According to the proposal, this exceptional contribution should amount for established countries € 1000 and for new countries € 500, but should nevertheless not exceed the annual membership fee (Luxembourg).
