
Note for the Attention of the Aemh members**Explanation on the Closing of Accounts AEMH 2008**

The financial situation of AEMH (+ 2178.44 Euros on the Dexia account), does not reflect the surplus of the year 2008 (15,630.57 Euros), because we must take into account the fact that the current account of AEMH had a negative balance on 31/12/2007 (16,450.84 euros) as a result of losses carried forward from previous years.

This amount was then transferred as debt of AEMH from the accounts of 2007 to 2008.

In 2008 the AEMH make a surplus of 15,630.57 Euros thanks to the exceptional one-off contributions of members and Price Waterhouse Coopers.

These contributions have enabled AEMH to clear its financial position of 2007 from a negative 16,450.84 Euros into a positive 2.191,03 Euros
