1. Election of Chair and Rapporteur

The participants agreed that the meeting would be chaired by Dr Radziwill and the report prepared by SG Birgit Beger.

2. Approval of the Draft Agenda

The draft agenda was approved.

3. Approval of the Minutes of the past EMO Meetings

Draft Minutes EMO PCom Kos, 11 June 2011 Draft Minutes EMO PCom Naples, 9 October 2011 (to follow)

The draft minutes of Kos and Naples were agreed; the draft minutes of Naples with amendments from Dr Mohrhardt circulated on 25 November 2011.

4. Follow up of the Naples meetings:

EMOs Joint Statement on the Professional Qualifications Directive:
 Dissemination and Feed-back

EMO Joint Statement PQD 11-2011

a) Joint statement on the revision of the Professional Qualification Directive

UEMS and EMSA accepted the joint statement. Dr Maillet regrets that European standardisation of training is not part of the text. Dr de Deus noted that AEHM could not have agreed to the first version which included the issue of European standards. It was suggested, that in countries where NMA is the competent authority (chambers), its role in the recognition process should be stressed.

Action: It was agreed that CPME would do the technical work of circulation.

b) <u>UEMO request on joint statement of Family Medicine (FM) as speciality</u>

The presidents discussed the UEMO request on a joint statement on the recognition of FM as a speciality circulated to some of the EMOs presidents list. Only Austria, Bulgaria, Belgium, Italy and UK apparently do not have FM as a specialty. Dr Kalan, Dr Mohrhardt and Dr Maillet will have to get the approval of their organisation before a joint statement can be made.

Action/Conclusions: Dr Radziwill circulated the document and will gather signatures.

5. Alliance Collaboration:

Rules of procedure and Management of documents between the EMOs

Background EMOA ROPs PCom (to follow) EMOA Agreement on Mutual Cooperation: Porto document (2009Dec05)

Dr Popović referred to the revised rules of procedure as already presented at a previous meeting. One new article was added. Dr Wetzel noted that no new organisation should be created; a minimum platform for political action should be created as formulated in Art.12.

The agreement could have the rules of procedure as an annex.

Dr Radziwill has serious personal doubts on the structure and formalisation proposed by the documents. He would need to get the approval of the CPME. However, any supra-organization or structure like EMOA was never supported by the CPME. Dr Mohrhardt raised similar concerns. Dr Pruckner and Dr Maillet, Dr de Deus and Ms Ene (the latter three with the caveat that some light rules could be useful) also noted that a new supra-organisation is not necessary.

Action/Conclusion: A revised, coordinated version of the ROP will be prepared and further discussed at the next meeting. Dr Mohrhardt will set up support tools for mailing lists and calendar.
