Opening of the session by AEMH-President Joao de Deus at 10:00.

## 1. Approval of the Agenda

Catherine Hartmann asked to add the topic of Domus Medica to point 8 and the EPHA Manifesto at her point 6.

Thomas Zilling asked to add the document which has been circulated concerning CPD in the Professional qualifications directive under point 5: EMO Collaboration.

In addition, the President reported that the Turkish Cyprus Medical Association invited him to lecture on "Doctors' involvement in Hospital Management in March.

Vlad Tica asked a mandate to approach the Moldavian Medical Chamber, which has been created recently and might be interested to join the AEMH. It might be too late to attend as

observer the upcoming meeting in Stockholm. The Board opinions were that, in absence of a Senior Hospital Doctors' Organisation, we should invite the Moldavian College of Physicians.

Furthermore, *Vlad Tica* reflected on clinical leadership as an expertise, which AEMH should push on the European area and set up a curriculum. He gave the Royal College as an example. This could be launched by a conference, but before he asked to brainstorm first within the board, then within a working group during the meeting in Stockholm. We have to differentiate between clinical leadership and hospital management.

*Hrvoje Sobat* wondered about the Swedish models, and why so many nurses are involved in management.

Thomas Zilling explained that clinical leadership is not well remunerated as in other countries. Furthermore, doctors prefer to concentrate on their clinical work.

Joao de Deus informed that in Portugal it is impossible that a nurse becomes head of department.

**Conclusion:** the members of the board are requested to send their ideas to Vlad Tica, deadline end of March .

For Stockholm the working groups of last year will be renewed.

Vlad Tica requested how the Paris (The European Hospitals) Declaration has been promoted. The document has been endorsed by FEMS and UEMS seemed in favour as well. Catherine Hartmann has sent it to the Commission.

**Conclusion:** It was decided to take the document <u>AEMH 13-052</u> to the EMO presidents meeting.

Thomas Zilling expressed concerns regarding CPD within the Professional Qualification directive. He reminded the Basel declaration, which is based on quality improvement, quality assurance and quality control. He fears that quality assurance might become mandatory. He proposes to convince the other EMOs for clarification of quality control within a conference. He gave the example of the UK, where revalidation is mandatory, which costs a lot of money, and there is no evidence of the benefit.

FEMS-President Enrico Reginato thanked the participants for coming to Catania.

## 1. Approval of the Agenda

The agenda was approved.

## 2. Update on respective activities FEMS

• Main topic is the organisation of the Action Day 15 May 2014. The aim is to organise a common presence in Brussels and to organise national activities at the same day. As all countries are not represented in FEMS, he requested the help of UEMS, which was promised. Furthermore, Enrico Reginato will meet Mathias Maucher from EPSU. EPSU has a great experience in the field of union actions. He informed on the action day on 7th February in Brussels of a Brussels based organisation called "Platforme for Health and Solidarity". Bernard Maillet will attend on behalf of FEMS. FEMS will invite a member of this organisation the 15 May.

The national organisation of FEMS will be asked to promote the action day on their website and send out the flyer and print the poster, which has been elaborated by Enrico Reginato. *Bojan Popovic* reminds the importance of having the right contact in the national organisation to relay the right information.

Joao De Deus informed that the Portuguese trade unions and the chamber organise together a conference and a press conference. Concerning the AEMH, they send out the document to its delegations. The national actions are left to the appreciation and needs of the countries. Thomas Zilling proposed to give the possibility to undersign the document on the website and have a counter showing how many doctors subscribe to the action.

Other possibility is to call everybody present on facebook to Like the document. A Press release should be issued before the action day.

- The survey on Doctors Salaries needs updating, unfortunately many countries are still missing.
- FEMS next meeting will take place 8-10 May 2014 in Gorizia/ Nova Gorica, a twin-town on the Italian-Slovenian border.
- FEMS will celebrate its 50<sup>th</sup> Anniversary 9-10 October 2014 in Paris.

## **AEMH**

Joao de Deus thanked for the hospitality and reported on the activities.

- AEMH plenary meeting and 50<sup>th</sup> anniversary in May in Paris. The Conference was entitle
   "Role, practice and future of hospital physicians". The AEMH held two parallel working
   groups: Professional Qualification / Training and on the Role, Practice and Future of Senior
   Hospital Physicians, which resulted in two statements. The European Hospital Physicians
   Declaration has been endorsed by FEMS and will be proposed to the other EMOs.
- AEMH presence at European events: in the UK at the Centre for Medical Education in Context (Centre for Distance Learning); in Goa at the "International Congress of medical

Cooperation", at the Med-e-Tel Conference in Luxembourg, together with Enrico Reginato at the Conference "Efficient Hospital Management" in Moscow, at the IDC's Pan-European Healthcare Executive Summit 2013 in London, and at the 2<sup>nd</sup> European Hospital Conference, co-organized with HOPE and EAHM (European Association of Hospital Managers) in Düsseldorf.

In 2014 Joao de Deus will speak at the 2nd International Congress Medical Cooperation in Cardiology 16-19 February in St. Petersbourg, and will attend the UEMS CME conference end of February in Brussels.

## 3. AEMH-FEMS bilateral Collaboration

## Common secretariat

Joao de Deus expressed the expectation to finally receive a proposal from the UEMS to join the domus medica, which we are willing to do if we are offered to pay the same rent as now in the CPME premises.

Catherine Hartmann reported that she has visited the UEMS premises and that the works will be completed this summer.

Brigitte Jencik explained that due to her retirement we should also endeavour to find a person who runs a common secretariat. Both activities together correspond to a half-time job and that therefore it is wise to pursue with a common secretariat instead of splitting. She has introduced her requests for pension for the 1<sup>st</sup> of May 2014 which means that she has to put an end to her activities at that date. The recruitment of a secretary in Brussels should not be too difficult for a start 1<sup>st</sup> April with one month double staffing for the take-over. She promised to remain as "back-up" in case of need.

Joint Meetings – Austria 2015 – Defining the sequence for the organizers

## 4. EMOs Collaboration

EMO Presidents' Committee Heidelberg

Enrico Reginato reported that he proposed again the document on standards. But the term was rejected and the document totally revised. He also announced the Action Day. The attendance at the CEN meeting and the question whether we should collaborate with them or not was discussed. The problem is that they do not listen to doctors, but to patients.

## 5. European Affairs, update

## a. Implementation of the Patients Rights Directive

EU countries had until 25 October 2013 to pass their own laws to implement

## Directive 2011/24/EU on patients' rights in cross-border healthcare

DG Health & Consumers launched a public consultation targeted to stakeholders on the implementation of European Reference Networks (ERN) and in particular on the criteria to be considered according to Article 12 of the Directive 2011/24/EU.

Patients will be only reimbursed if treated in public hospitals. It seems that there are many critics concerning the directive, which seems not yet implemented in many countries. Every country needs to have information points for patients.

The European Commission is considering its position with regard to the EWTD and is expected to publish a proposed revision in late 2014.

*Enrico Reginato* reported that the Italian case still has not changed. FEMS will write again to complain to the commission.

A discussion took place on the opt-out clause, which is in force in the current directive. Vlad Tica mentioned that in Romania the compensatory rest is not respected and asked what could we do about that.

## c. Professional Qualifications Directive

Thomas Zilling commented on the length of training 5 years and 5500 hours which came as a surprise in the new directive. Concerning the article on CPD, he fears that quality assurance might become mandatory. He proposes to convince the other EMOs for clarification of quality control within a conference. He gave the example of the UK, where revalidation is mandatory, which costs a lot of money, and there is no evidence of the benefit. Enrico Reginato advocated for a control of post graduate training.

Vlad Tica reported on the assessment of the EBCOG - European Board and College of Obstetrics and Gynaecology (Section of the UEMS).
