### Roberta Chersevani



Dr Roberta Chersevani was born in Trieste, Italy, where she graduated and specialized in Diagnostic Radiology.

She works up to March 2008 in a General Radiologic Dept. but is particularly dedicated – as far as research - to the diagnosis of breast diseases.

Dr Chersevani graduated from the Scuola Italiana di Senologia, directed by Prof. U. Veronesi; of the International Breast Ultrasound School; of SIUMB (Italian Society of Ultrasound in Medicine and Surgery).

She holds various positions in the board of EUSOBI – European Society of Breast Imaging, the SIRM (Italian Society of Radiology) and the Breast Subcommittee Member at the European Congress of Radiology since 2005.

Dr Chersevani is the Chairman of the Breast Subcommittee for ECR 2008.

Since 2007, she is President of the Medical Chamber of Gorizia, town where she lives and works as a radiologist in a private practice.

She has coordinated the working group of the FNOMCeO on the presence of women doctors in Italy as well as the Consulta Deontologica Nazionale of the FNOMCeO, which has redefined the Code of Medical Ethics in 2014.

Dr Chersevani was elected President of the FNOMCeO in 2015.

# Jacques de Haller



Dr Jacques de Haller was born in 1952; he graduated from Geneva University Faculty of Medicine in 1978 and specialized in General Medicine (1983). He worked as a GP in Geneva for 21 years (1983-2004).


He became President of the Swiss Association of General Practitioners for 4 years, in 2000. In 2004, he was elected President of the Swiss National Medical Association FMH, until December 2012.

During his 8½ -year mandate, he developed the association – representing 97% of the Swiss doctors – into becoming one of the major political lobbies in Switzerland. Correct tariffication, limitation of administrative burden on physicians, hurdle-free access for all patients to the needed medical care, and the preservation of a patient-doctor relationship, the core of medicine in his view, free of state or insurance interventions, were the main accents of his national presidency.

He was elected Vice-President of CPME in June 2012. On 1 January 2016, he became President of CPME.

He spends his time off at a very quiet spot, an old house in the countryside near Lausanne.

#### **Paul Vincke**



Paul Vincke is a Director of Staff at the Service of Medical Evaluation and Control (SECM) of the National Institute for Health and Disability Insurance (NIHDI) in Belgium and Managing Director of the European Healthcare Fraud and Corruption Network (EHFCN).

He has obtained a degree in Criminology at the Katholieke Universiteit Leuven, Belgium.

Within EHFCN Paul Vincke has been Treasurer and Deputy Director-General since October 2005. He was elected President in 2007 and continued to represent the Network in this function until he was appointed Managing Director of EHFCN on 1 January 2013.

**Enrico Reginato** obtained his degree in Medicine and Surgery from the Catholic University of Rome (1971). As specialist in Cardiac Surgery and in Vascular Surgery, he acted as a cardiac surgeon between 1972 and 2008 at Massa Hospital (later ASL1 Regione Toscana). He holds a Master in Bioengineering from Pisa University (1980) and a Master of Direction, Organization and Management of Sanitary Companies from Tor Vergata University (Rome) (1977).

He has been member of the Tuscany Regional Committee for Accreditation of Healthcare Structures between 2004 and 2011.

He has been a representative of ANAAO-Assomed (Italian Association of Executive Hospital Doctors) since 1978. He is the president of FEMS (European Federation of Salaried Doctors) since 2012.

Enrico Reginato is an expert for Cardiac and Vascular Surgery for Milano, Catania, Siracusa and Rome Tribunals.

**Erich Theo Merholz** obtained a dual degree as a Medical Doctors and Doctor of Dentistry from the University of Düsseldorf and a PhD from the same university in 1977.

Since 1986 he is the director of the department of oral and maxillo-facial plastic surgery of "St Lukas Klinik", Solingen, Germany.

He was the President of the German Society for cranio-maxillo-facial surgery between 2010-2012. He is the co-founder and honorary member of Deviemed (German-Vietnamese society for the advancement of medicine). He is also in close cooperation with the Hue Central Hospital (Vietnam) and with the National Hospital Loyaza (Peru) in the field of cleft lip and palate surgery.
