## **INTERNAL AUDITOR'S REPORT**

In compliance with Article 15.5 of the AEMH Statutes I carefully analyzed and evaluated analytically the Closing of Accounts 01.01.2016-31.12.2016 established by the Experts-Comptables Associés (E.C.A.) and verified that the budgetary actions are taken in accordance with the aim and the Statutes of the AEMH and with the Financial guidelines, revised and adopted in 2009.

I hereby confirm that I have no objections in this respect.

The comparison between the budget 2015 and the accountancy 31/12/2015 shows also for the year 2016, a surplus due to a careful and prudent management by the Treasurer, Dr. Hrvoje Sobat. In fact in the year 2016 the AEMH spent less than planned for the budget items.

Remarkable is that all delegations with the exception of Slovak delegation (until today) had paid their duties timely and that the Portuguese Ordem dos Medicos supported most of the activities of our President, therefore contributing in further increasing our savings.

A thanks also to the Italian Medical Association (F.N.O.M.C.e.O.) that hosted the meeting of the last year of AEMH in Naples.
