Members of the Executive Committee and Members of Assembly.

It is with great pleasure that CEOM is present in this meeting.

During last year, CEOM essentially reinforced the position in what we are involved:

- Medical ethics and professional conduct
- Free movement of professional health care
- Medical regulations
- Professional training of physicians
- Public health issues related to these subjects

On the last meeting, in Madrid, on December 2018, we approved the new code of the European Charter for Medical Regulation and the new deontological guidelines about human enhancement and vulnerable patients.

A common document from Portugal and Spain, supporting the Doctor-Patient Relationship as Intangible Heritage of Humanity of UNESCO, and the CEOM declaration regarding violence against health professional, were also approved.

About this last subject, we are delighted to announce the AEMH proposal for join CEOM in a working group.

We believe that the collaboration between EMOS associations is still on the topic of the day, and that has an important role in the defense of physicians, quality of patient care and ethical practices in Medicine.

Following these thoughts, it's important:

- The developing and the materialization of the program of CPD/CME,
- The statement on the role of physicians and the increasing importance of the leadership on the multidisciplinary teams,
- The EMOS statement on supporting vaccination in 2018
- The issue of maintenance of the clinical competence (revalidation, recertification).

Our next CEOM meetings, will take place in Tirana 6-7 June, and after that in Lisbon in 28-29 of November. On CEOM meeting in Lisbon, on 30 of November, we are very pleased to announce that we will welcome the next EMOS presidents meeting.
