

AEMH Country Report Italy May 2022

Focus on "The condition of doctors two years after the start of the Covid -19 pandemic"

On 21 April 2022, within the framework of the "Conference on conditions of medical personnel" organised by the FNOMCeO in collaboration with all the Italian medical unions, in the presence of the Minister of Health, Roberto Speranza, and the President of the Conference of Regions and Autonomous Provinces, Massimiliano Fedriga, were presented the results of the survey commissioned by the FNOMCeO to the Piepoli Research Institute on "The condition of doctors two years after the start of the Covid-19 pandemic", a survey conducted on a statistical sample of 500 Italian doctors, interviewed between 21 and 28 March 2022 using the CATI (Computer Aided Telephone Interviewing) method.


According to the research, the workload increased for 3 out of 4 doctors during the pandemic (for general practitioners the workload increased by 75 per cent, for hospital doctors by 70 per cent).

Almost 1 in 5 hospital doctors had to change departments, finding themselves in difficulty in 75% of cases.

On the other hand, 53% of doctors state that many citizens have given up important treatments. 53% of patients did not start a treatment because of the pandemic, 41% of patients stopped a treatment because of the pandemic.










In addition to the normal daily routine, remote consultations and visits have invaded the private lives of Italian doctors, 3 out of 4 of whom are no longer able to go on holiday or even to guarantee themselves adequate time for personal life.

74% of general practitioners and 66% of hospital doctors consider the free time for their private and family life to be inadequate.


For the majority of Italian general practitioners and hospital doctors, holidays have been reduced or denied.



The doctors called for greater institutional attention to their condition, which has so far been insufficient for the majority of those interviewed.

The FNOMCeO President, Filippo Anelli, at the end of the Conference on 21 April, noted how appropriate it would seem at this point to establish a National Observatory on the protection of the rights and working conditions of doctors, with consultative status, at the Ministry of Health, in order to monitor precisely the respect of workers' rights.
