

**FIG. 1.3** Belgian regions and communities






 Health policy and regulation is divided among the Federal state and the federated entities

- More than 20% of the health budget has been transferred to the federated entities
- The covid-19 pandemic highlighted a serious problem of decision-making and management related to the multiplicity and dispersion of responsibilities and stakeholders in public health issues and in particular in case of a health crisis




FIG. 2.1 Overview of the health system: organisational relationships between the main actors (simplified schema)




- The health care system relies on a model of compulsory health insurance, administered by sickness funds.
  - 99% of Belgian residents is covered with no selection of health risks.
- Reimbursed health care services are provided by both public and private institutions and individual health careproviders.
- Approximately every two years, health practitioners can choose between a conventioned or non-conventioned status which allows for an extra-billing charge under certain conditions.
- The patients rights are enriched in a law.










FIG. 3.2 Trends in current health expenditure as a share (%) of GDP in Belgium and selected countries, 2000–2017





FIG. 3.3 Current health expenditure in US\$PPP per capita in the WHO European Region, 2017







FIGURE 4.9 – Densité de population belge en 2019





FIG. 4.1 Curative care beds in hospitals per 100 000 population in Belgium and selected countries, 2000–2018





Figure 2. Comparaison des pyramides des âges des médecins généralistes actifs dans les soins de santé, pour la Belgique, 2011 vs 2021




FIGURE 4.1 – Évolution du nombre d'activités de médecins en Belgique entre 1989 et 2019
